



1. Quotation on plain paper addressing the Medical Superintendent & HOD, AGMC & GBP Hospital, Agartala shall reach the office of the Medical Superintendent & HOD, AGMC & GBP Hospital, Agartala, either by mail/courier or in person on or **before 05.00 pm on 20.03.2025.** Quotations shall have to be enclosed in sealed envelopes super-scribed as **"Quotation for procurement of certain equipment's for use at AGMC & GBP Hospital, Agartala, Pin-799006.**
2. Any quotation received after the aforesaid timeline shall be liable to be summarily rejected. The Medical Superintendent & HOD, AGMC & GBP Hospital shall not be liable in any manner for any delay occasioned or failure caused in delivering a quotation within the prescribed timeline as aforesaid.
3. The quotationers shall mention their full name, address and contact number on envelopes.
4. Quotations received in due manner are likely to be opened next day after end date of submission, in the Office of the Principal, AGMC, Agartala, unless postponed for any unfrozen reason. Quotationers can be physically present to witness the quotations-opening proceeding (no separate notice will be issued to this effect to any quotationer).
5. Self-attested photocopy of relevant up to dated & valid (i) Trade license (ii) OEM Manufacturing License, if bidder is not OEM than Authorization certificate from OEM, (iii) PAN Card (iv) GST Registration certificate & Last GST return copy, (v) Acknowledgement copy of Income tax Clearance certificate. (vi) Compliance sheet of technical specifications
6. The Technical committee of the hospital shall have the right to waive off any of the aforesaid requisites in deserving cases
7. Rate should be quoted inclusive of all taxes.
8.
